### **Past Projects with Special Environmental Considerations.**

Wreck Removal of F/V Kris Schell from Annisquam River Gloucester MA. The USACE contracted with Burnham to remove a derelict fishing vessel that had been found to contain TASCAs levels of PCB's. The vessel was stabilized, righted, and floated. It was then towed down river. To a shipyard for demolition. The wreckage was reduced and loaded into watertight roll off containers for disposal.

Maintenance dredging of Pawtuxet cove in Cranston and Warwick Rhode Island. The upper reaches of Pawtuxet cove were found to contain a variety of contaminants, but primarily hydrocarbons related to fuels. The project owner USACE required the use of an Environmental bucket .on the project.

Old Colony Yacht Club. Permits for the dredging of Old Colony Yacht club required the use of an Environmental bucket, a silt curtain and constant turbidity monitoring. This was due to the project site being one part of a much more heavily contaminated site owned by then KeySpan, now National Grid.

Maintenance dredging of Riverview Marina Danvers MA. Although suitable for offshore disposal the permits for the dredging of Riverview Marina included requirements for Closed environmental buckets, turbidity curtains and turbidity monitoring.

CAD Cell Construction for the New Bedford Harbor Commission. This was undertaken in June and July of 2008 with emphasis on minimizing water column particulate as it contained low levels of PCB's. Spoils were dredged and loaded into scows and held for up to 72 hours before being allowed for disposal into another CAD Cell. Debris that was encountered was selectively extracted from the spoils and disposed of on shore in role on dumpsters.

Maintenance dredging, Old Saybrook, CT, USACENED, with special capping procedures for Central Long Island Disposal site. Project involves the dredging and removal of 200,000 cu. yds. of clean mud from the North Cove. 75,000 cu. yds. of this material will ultimately be disposed of at CLIDS. This capping material culminates the season's dredging throughout Connecticut and New York with clean dredge material. Contacts for these projects can be found in the experience summary.
